Correctness - the speech of the teacher must comply with all the norms adopted in the Russian language. Incorrect pronunciation of words, incorrect construction of sentences, the presence of parasitic words is not allowed.

Goodwill and respect for the opponent. Speech etiquette does not allow aggressive statements, profanity, in relation to a particular person, group of people or situation.

The culture of speech is a special area of pedagogical technology and acts as an external indicator of the level of the general culture of the teacher, the main instrument of his pedagogical interaction with students. Distinctive features of the pedagogical culture of speech are clarity, brevity, correctness, relevance, emotionality. In the end, I would like to conclude that the teacher should always, it is his duty to speak politely, respectfully and not show and express his aggression. The teacher, for young children, is like a protector, like a support and also acts as a parent, therefore, the right words, the right intonation and speech make the impossible possible.

Pedagogical duty

Pedagogical duty is one of the most important categories of pedagogical ethics. It concentrates ideas about the totality of requirements and moral prescriptions imposed by society on the personality of the teacher, to fulfill them their professional duties.

They provide for the implementation of certain labor functions, the correct construction of relationships with students, their parents, work colleagues, a deep awareness of their attitude to the chosen profession, student and teachers and society as a whole. The basis of professional pedagogical duty is the objective and actual needs of society in the education and upbringing of the younger generations.

It also provides for the need for a creative attitude to one's work, special demands on oneself, the desire to replenish professional knowledge and improve pedagogical skills, the need for a respectful and demanding attitude towards students and their parents, the ability to resolve complex conflicts of professional activity.

Pedagogical honor in pedagogy is a concept that expresses not only the teacher's awareness of his importance, but also public recognition, public respect for his moral merits
